Robert Smith skaters look sharp in new gear

A Selkirk and District Community Foundation grant of \$4,475 bought skates, helmets and sticks for Robert Smith School's Wednesday afternoon skating program, but it also revived interest among kids who had stopped coming.

Teacher Rhonda Hopkins, who started the program almost 15 years ago as a once-a-year field trip, said the much-needed new equipment brought out kids who they hadn't seen in a while.

"The kids are so excited to come skating," Hopkins said, noting that

as many as 40 kids are on "The Barn" ice in Selkirk each week.

"Kids that we hadn't seen in a couple years, that maybe had skates passed down to them, they're back skating again since the equipment's come in."

The grant also helps pay for sharpening of the skates, and Hopkins said they have plenty of sharpening to do because the new equipment has kept kids coming all winter long.

"Usually there's that enthusiasm at the start of the season but it's been maintained throughout the season because we have kids that aren't in the organized sports that are participating now," she said.

"It's been fabulous in the respect that, they're excited."

Hopkins, along with several parent volunteers, help with tying skates and

assisting the kids on the ice. The program has grown over the years, and is now a school-wide, weekly program that culminates with a finale in March when the kids are treated to a last skate at the Rec Complex.

What are our vital signs?

We all feel that we know our community really well. But do we?

Do we know how many people are homeless in our communities? How many students graduated from high school year after year? How welcome and included do immigrants, the elderly or Indigenous residents feel in our community? What makes our community stronger and where is it weak?

And if we knew the answers to these questions and many others, would we create and fund community initiatives differently?

Across Canada groups like the SDCF have been taking the pulse of their communities with a study called Vital Signs, designed by Community Foundations of Canada. Communities as

small as Winkler and as large as Winnipeg have participated in Vital Signs reports and learned more about their community

through careful collection and analysis of statistics and data.

This year the SDCF will be asking you and leaders in our community to take the pulse of Selkirk, St. Clements and St. Andrews to help us make better and informed decisions about how to make our community better for everyone.

Our goal is to raise awareness, rally support, collect funds and conduct the work in 2016 to complete the study by 2017 for Canada's 150th birthday.

Bike program gets rolling with Foundation seed money

Four thousand dollars in seed money from the Selkirk and District Community Foundation has put the wheels in motion for the Lord Selkirk Education Centre's Bike Program, and director Steve Grahame says the road ahead is definitely paved with good intentions.

Students at the Centre, along with two Community Living Selkirk individuals, are learning how to fix and rebuild bikes. Next they'll go to elementary schools in the Lord Selkirk School Division and teach kids how to fix their own bikes.

Grahame said the grant money allowed them to buy tools and a trailer to haul their gear and bikes, to schools. They'll teach kids how to fix their own bikes, if they have one. Kids without bikes will be able to get a bike from those donated by the City of Selkirk which collects abandoned two-wheelers.

"It works with my atrisk youth, it works with the people from Community Living, it works with kids in the community that need their bikes fixed and it also teaches skills to

those kids so they can fix their own bikes. Really the money that was provided is just the tip of the iceberg and it really lets us expand the program in all sorts of different areas in the community."

Honouring and remembering a beautiful young woman

On a beautiful June day last summer, Rick and Laurie Sutherland and close to 300 friends and supporters, paid tribute to the couple's daughter in wonderful fashion, ensuring a young woman taken far too soon, would leave a lasting legacy, and boost other young lives for years to come.

The Sutherlands held the first annual Kirstin's Walk for Kids in memory of Kirstin, their daughter who passed away following a vehicle accident in September 2014. She was just 27 years old.

While there have been many difficult days since Kirstin's passing, Rick called the day of the walk "a perfect day". Perfect because it honoured Kirstin, but also because it raised funds for the newly created Kirstin's Walk for Kids Endowment Fund, managed by the Selkirk and District Community Foundation.

Rick said they started the fund after realizing people had already donated money to the foundation in Kirstin's memory. He and Laurie consulted with the walk's committee, then contacted the foundation, and established the fund.

"Everything seemed to fit," Rick said.

They raised more than \$10,000 and, along with money raised through a raffle, were able to establish the fund and give an immediate gift to two local child care facilities – Interlake Nursery Coop, where Kirstin attended as a child, and the Rivercrest Early Learning Child Care Centre, where Kirstin worked as an adult.

Rick and Laurie say Kirstin would be thrilled with the walk and the fact it's helping young children.

"Focusing on doing this, it was a wonderful thing in so many ways. It was a success in so many ways, not just financially but just the people that came out and the way the walk went," Laurie says.

"It really comes down to honouring her and remembering her. She would have done the same."
